Nitric oxide (NO) is a colorless, orderless gas. Nitrogen dioxide (NO2) is a reddish-brown gas with a highly pungent, bleach-like odor. Exposure can cause irritation to eyes and respiratory system and effect the central nervous and cardiovascular systems. Severe overexposure can be fatal. This hazard does not exist when mixed with other admixtures in concrete.

Breathing equipment:
